## CEDAR COUNTY NO PARKING ORDINANCE

### ORDINANCE NO. 24

AN ORDINANCE TO ESTABLISH NO PARKING AREAS ON CEDAR COUNTY ROADS AND STREETS AND TO REGULATE PARKING ON ALL COUNTY HIGHWAYS AND STREETS DURING WINTER SNOW REMOVAL SEASON.

#### BE IT ORDAINED

#### BY THE BOARD OF SUPERVISORS CEDAR COUNTY:

## SECTION 1 -- PURPOSE

The purpose of this ordinance is to establish portions of this County's roads as no parking areas. The Board of Supervisors is empowered under the authority of Sections 321.255, 321.236, 321.239, and 321.354 of the Code of Iowa to regulate the standing or parking of vehicles on streets and highways under its jurisdiction and to place and maintain appropriate traffic control devices. Additionally, this ordinance establishes some county streets and highways as snow routes with parking prohibited during snow removal operations to ensure passage of snow removal, fire, and emergency vehicles and for the safety of pedestrians and the traveling public.

### SECTION 2 -- PERMANENT NO PARKING ZONE LOCATIONS

- 1. In the Town of Rochester, on the south side of Washington St. from 100 feet east of the intersection of Second St. to the intersection of Washington St. and Third St.
- 2. In the Town of Rochester, on both sides of Third St. from the intersection of Cedar St. and Third St., north through the intersection of Washington St. to the alley east of 1727 Washington St.
- 3. In the Town of Cedar Bluff, the east and west sides of Second St. from the intersection of Second St. and State St. northerly to the intersection of Second St. and 210th St.
- 4. In the Town of Cedar Bluff, on State St. from the intersection of State St. and Third St. easterly to the intersection of State St. and 210th St.
- 5. In section 25, township 80 north, range 3 west on Logan Ave approximately 3680 feet northwest of the intersection of Logan Ave and Highway 38. The no parking zone is on the east and west sides of the road and is 750 feet in length.
- 6. In section 18, township 82 north, range 4 west, in the platted subdivision known as Yankee Grove Subdivision, parking is prohibited on both sides of all subdivision streets.
- 7. In the unincorporated area known as West Rochester, no parking will be allowed from 165 feet north of the intersection of West Rochester Rd. and West Rochester Ave. to a distance of 1700 feet north of the intersection on the east side of Rochester Ave. and from 165 feet north of the aforementioned intersection then north 1750 feet on the west side of Rochester Ave.
- 8. In the Town of Downey, no parking will be allowed on the south side of Broadway St. between Dillon St. and Baker Ave., also known as County Highway X30.
- 9. On County Highway F28, also known as 210th St., no parking will be allowed at a cemetery entrance 150 feet east of the intersection of 210th St. and Eureka Ave.

#### SECTION 3 -- SEASONAL AND SNOW REMOVAL NO PARKING ZONES

- 1. In the Town of Cedar Bluff, from 12:00 A.M. July 3 through 11:59 P.M. July 4, on the north side of State St. between the intersections of State St. with 210th St. and Second St.
- 2. In section 19, township 82 north, range 4 west, on both sides of Adams Court, no parking will be allowed following snowfalls exceeding 1" or freezing rain in any amount. Parking will not be allowed until 48 hours after snow removal operations have been completed. Adams Court parking restrictions will be effective following signing.

# **SECTION 4 -- PENALTIES**

Vehicles found illegally parked and unoccupied on county roads at any of the abovementioned locations or during snow removal operations and "emergencies" as defined in Cedar County Ordinance Number 6 will be subject to ticketing for illegal parking with a fine of up to \$5, per Section 321.236(1)a, Code of Iowa and may be towed immediately. Vehicles parked on designated snow routes may be fined up to \$25 per Section 321.236(1)a, Code of Iowa and may be towed immediately. The towing of these vehicles will be at the owner's expense.

## **SECTION 5 -- REPEALER**

All ordinances and resolutions, or parts thereof, in conflict herewith are hereby repealed.

# **SECTION 6 -- SEVERABILITY**

If any section, provision, or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision, or part thereof not adjudged invalid or unconstitutional.

#### SECTION 7 -- WHEN EFFECTIVE

This ordinance shall be in effect immediately after its final passage and publication as provided by law.
