RESOLUTION ORDERING A SPECIAL ELECTION ON AN AD VALOREM PROPERTY TAX FOR EMERGENCY MEDICAL SERVICES

WHEREAS, the Cedar County Board of Supervisors has declared emergency medical services an essential service and did so in compliance with Iowa Code Section 422D.1(2)(a).

WHEREAS, the Cedar County Board of Supervisors coordinated efforts with local emergency medical services agencies to establish a county emergency medical services system advisory council to assist in research and assessing the service needs of the county and guiding implementation of services in the county within a council structure.

WHEREAS, the Cedar County Board of Supervisors is in receipt of a recommendation from the county emergency medical services system advisory council, which recommends funding at a level of \$.75 (Seventy-Five Cents) per \$1,000.00 (One Thousand Dollars), of assessed value on all taxable property within the county and said recommendation is on file with the Cedar County Board of Supervisors, and has been examined by the Cedar County Board of Supervisors, who have determined that it otherwise complies with Iowa Code Section 422D.1(2)(c).

WHEREAS, the question for the imposition of the ad valorem property tax or any other proposal incorporating any portion of it has not or will not be submitted to the qualified electors of Cedar County, Iowa, for a period of at least sixty days subsequent to the publication of the notice of the question, so as to comply with Iowa Code Section 422D.1(3)(a).

NOW, THEREFORE, IT IS RESOLVED BY THE CEDAR COUNTY BOARD OF SUPERVISORS, STATE OF IOWA:

Section I. That an election is called of the qualified electors of Cedar County, Iowa on Tuesday, November 7, 2023. The following Proposition is approved, and the Auditor is authorized and directed to submit and file the Proposition for the Ballot with the Cedar County Commissioner of Elections at least 60 days prior to the election.

PROPOSITION

Shall the Cedar County Board of Supervisors be authorized to implement a property tax, for a period not to exceed fifteen (15) years, for the purposes of creation and maintenance of an essential county-wide emergency medical service (ambulance). The amount would be \$0.75 (Seventy-Five Cents) per \$1,000.00 (One Thousand Dollars) of assessed value on all taxable property within the county. This program will enhance and strengthen our essential community ambulance service through the provision of professional, paramedic level emergency care, reduction of response times, and improvement of patient care outcomes.

[END OF BALLOT LANGUAGE]

Section 2. That the notice of the election and ballot form used at the election shall be prepared in accordance with the provisions of the Iowa Code and Iowa Administrative Rules.

Section 3. That the Election Board for the Voting Precinct or precincts be appointed by the County Commissioner of Elections, not less than 15 days before the election.

Section 4. The Commissioner of Elections for Cedar County is requested and directed to make publication of the Notice of Election at least once, not less than four days nor more than twenty days prior to the election, in a newspaper that meets the requirements of Section 49.53(2), Code of Iowa.

Section 5. That the County Commissioner of Elections for Cedar County shall prepare all ballots and election registers and other supplies necessary for the proper and legal conduct of this election.

Section 6. That the Auditor is directed to file a certified copy of this Resolution in the Office of the County Commissioner of Elections of Cedar County to constitute the "written notice" to the County Commissioner of Elections of the election date, required to be given by the governing body under the provisions of Chapter 422D, Code of Iowa.
